- **With Excess capabilities of up to USD 9,900,000 dependent of the risk**

### Excess Motor Truck Cargo (XS MTC) – *No Excluded Goods*

#### Limits

- USD 9,900,000 any one Loss Excess of Primary Minimum USD 100,000 any one Loss
